

London Borough of Hammersmith & Fulham Third Sector Investment Fund (3SIF) Grant Outcomes and Criteria

1. Introduction

H&F has launched an ambitious new Third Sector Investment Strategy, to help support residents across our borough. This scheme has, for a long time, had far reaching positive impacts on our communities, and we value the skills, diversity, and independence that our partners bring in supporting our residents to thrive. The purpose of the fund is to directly support our residents with specialist services that the sector is best placed to deliver, and the aim of this new grants round has been refined to align with the ambitions of the <u>H&F Plan</u> <u>2023-2026</u>. We want to help maintain a strong and capable third sector that is well equipped to support our rapidly changing communities, and help build stronger, more active, and more connected communities across our borough.

The Council (in common with all public sector services) continues to face significant financial challenges with increasing pressures on many services. This will necessitate an on-going review of all services – including funding to external contractors and organisations. The Council is committed to full transparency and accountability for the ways public money is spent, and reductions in available funds are making this more important than ever. It is therefore important that this investment delivers outcomes over and above those already delivered by the Council. There will be an expectation that successful organisations are able to showcase and demonstrate the outcomes being delivered.

New grant agreements will be issued and will contain clearly defined break clauses and conditions of monitoring. There will be three tiers of grants: below £10,000 (tier one), between £10,000 and £34,999 (tier two), and above £35,000 (tier three). Tier one will prioritise applications from otherwise unfunded groups. The new tiers will tighten the monitoring process and requirements and make monitoring requirements proportionate to the level of funding awarded.

Applications will be assessed for eligibility. Those not meeting eligibility requirements set out in the application form will be set aside. Eligible applications will be forwarded for assessment. This document identifies the outcomes we want for residents, and sets the criteria that will be used to assess and allocate grants through a prioritised and competitive application process which is open **until 9am on 1 October 2024**. This document should be read in conjunction with the application form.

2. Monitoring

We are introducing a new modernised monitoring approach. This places a focus on agreed quantitative and qualitative measures and outcomes, and successful grant organisations will be expected to be compliant with this new approach. Grant Agreements will be signed between the Council and all successful organisations before the new grants are launched. This will include agreeing key performance indicators or targets with organisations that they can meaningfully report against. Grant Agreements will set out the terms and conditions that need to be met for the organisation to receive continued funding. Breaches to the Grant Agreement may impact funding.

4. Our priorities

H&F's Cabinet agreed on 15 July 2024 the seven priorities for this round of investment:

- Building a better future for children and young people
- Promoting healthier, longer and more independent living
- Promoting fairness, equity, and inclusion across our borough
- Preventing poverty and its impacts
- Making H&F a great place in which to live, work and thrive (includes sports & culture)
- Creating a safer and resilient borough for everyone
- Tackling the climate emergency

This document sets out the outcomes we want grant recipients to help us achieve under each of these areas, alongside an overarching set of criteria that we expect all grants to meet.

5. Application criteria

All applications will be scored against the criteria set out in this document.

<u>APPLICANTS MUST</u> demonstrate how they meet the following criteria areas: collaborative, inclusive, preventative, demonstrates impact, well organised, adaptable and value for money.

<u>APPLICANTS MUST ALSO</u> identify the outcomes that their service, project or activity will deliver based on the outcomes listed in this document. Applicants must meet at least one (or more) of these outcomes and **directly quote these outcome(s) within their application**.

We do not wish to fund services that duplicate existing provision (whether statutory, commissioned, or existing third sector provision) or services that do not deliver the outcomes in this document.

6. Criteria that all grant applications must meet

We have devised a set of criteria to set the standards we expect of grant recipients and the outcomes they should achieve. These criteria were devised to having regard to feedback received from the sector during the previous grants round. Our application form will ask applicants to address each of these criteria in turn. Each bullet point below the criteria identifies what we require to be met within applications. These are minimum requirements only, and applicants should go further to demonstrate how they exceed these where possible:

Collaborative: The organisation demonstrates an ability and commitment to work with residents and partners to co-produce their services and adapt positively to feedback, working together to achieve shared outcomes for residents and avoid overlaps in services:

- Evidence of co-producing services with residents (or plans to).
- Demonstrates a commitment to work with the wider sector towards shared objectives.
- Has an established complaints and compliments process.

Inclusive: The organisation operates in an inclusive way and ensures that all members of the community can shape and access the services they receive:

- Demonstrates a commitment to tackle discrimination and inequality.
- Demonstrates that they are an inclusive employer, support equal opportunities, and reflect the communities they serve.
- Demonstrates steps to remove barriers to inclusion, such as for Disabled residents or residents from economically disadvantaged backgrounds, including but not limited to: single-parent households, large families, and families from Black, Asian and Minoritised Ethnic Groups/global majority groups.

Preventative: The organisation demonstrates how the investment will support residents early, prevent escalation of issues, and support positive outcomes beyond the term of the grant:

- Demonstrates how the investment will prevent more acute service demands at a later stage.
- Demonstrates how the investment can help prevent the health and social care needs of borough residents escalating or deteriorating, including preventing the initial need for adult social care services, hospital admission or an increase in packages of care.
- Demonstrates a commitment to working with the council to promote the wellbeing of all residents.

Demonstrates Impact: The organisation makes a strong case for how the investment will help to achieve positive outcomes for residents, with demonstrable evidence of previous successes:

- Demonstrates the use of a specific, measurable, achievable, relevant and time bound (SMART) outcomes framework.
- Demonstrates a clear justification of how the grant will support the delivery of outcomes.
- Demonstrates a track record of delivering successful initiatives on time and in budget.
- Demonstrates a strong understanding of resident's needs and uses this together with research and evidence to justify the investment.

Well Organised: The organisation demonstrates clear plans, good governance, openness, and transparency, and can report in a timely and accurate way against outcomes and targets:

- Has clear processes for managing risks, issues and reporting against outcomes.
- Demonstrates evidence of realistic business plans and fundraising strategies.
- Demonstrates openness to scrutiny and transparency in how the organisation operates.

Adapts to changing needs of residents: The organisation demonstrates that they can adapt to meet new challenges and changes in demand during times of crisis or significant change, working together with the Council and other partners at all times:

• Demonstrates an understanding of how demands on their service and the needs of residents may change over time.

- Evidence of adaptability and collaborative working with the council during the Covid-19 Pandemic.
- Evidence of adaptability and collaborative working with the council during the Cost of Living crisis.
- Has a plan to attract and measure the number of new users to their service(s).

Value for money: The organisation demonstrates a commitment to ruthless financial efficiency, and how the grant will contribute positively towards other cross-cutting local priorities.

- Demonstrate excellent value for money and sound financial planning to maximise impact.
- Able to show how the investment contributes positively towards wider social, economic, and environmental outcomes (such as those set out in the Council's Climate and Ecology Strategy, Equalities Plan, and Industrial Strategies).
- Demonstrates how the investment will leverage further funding or resources from other sources (such as through matched funding, use of volunteers, community capacity building, existing partnerships, and use of existing equipment and facilities).

7. H&F's priorities and outcomes sought from grants

This section identifies seven priorities drawn from the H&F Plan 2023-2026, together with the outcomes we want to achieve in each area. Outcomes refer to the impacts (or, end results) of services to residents. <u>Applicants will be prompted in the application form to identify the outcome(s) in this document that will deliver</u>. In addition to the criteria listed above, applicants will be scored on their ability to show how their project, initiative, or service delivers on their chosen outcome(s). The application form will prompt to do this.

Under each priority we explain the types of services we would consider funding. This list is not exhaustive and identifies just some of the services that could be funded. We are open to considering grants for any type of project, initiative, or service that can deliver on the outcomes we want. Applicants applying to deliver grants in specialist areas, such as those involving the safeguarding of children, will be expected to meet enhanced requirements. These are set out in the relevant sections. <u>Applicants must show that they meet these requirements through their application.</u>

Example Services Sought

The types of services that we will consider funding, include, but are not limited to:

- Services that support children to attend school and achieve their full potential, tackling barriers to emotionally based school avoidance.
- Services that prevent escalation of need and/or reduce the likelihood that a child is referred to statutory services.
- Services that develop resilience and community capacity.
- Services delivered through activities outside school hours, 1:1 work, group work, mentoring, advice services and forums, direct work with schools and families.
- Services that develop life skills for young people that prepare them for adulthood and independent living.

Service Requirements

Due to the nature of services under this priority, organisations will need to demonstrate:

- A strong understanding of the issues affecting children in the borough (and their families).
- A strong understanding of services and provision available to children in the borough and how their proposed services will complement and support the overall offer for children in the borough over the course of the grant term.
- A track record of working locally to deliver measurable positive outcomes for children.
- That they are able to reach and maximise outcomes for vulnerable children. Vulnerable children may include but are not limited to: young carers; care-experienced children; children with SEND or additional needs; refugees; children with low attendance, at risk of exclusion, or at risk of being NEET; children from low-income families or living in areas of high deprivation; children on a child protection plan or known to social care.

- Utilisation of tools and resources to evidence improved outcomes for residents, linked to the Public Health Outcomes Framework
- Continuous quality improvement mechanisms
- Evidence of taking a partnership approach to delivering on outcomes such as activities with local businesses and health services
- Incorporating peer support in service delivery where possible
- Track record of working with Disabled People in line with H&F's Vision of Independent Living
- A commitment to maintaining up to date knowledge of best practice in line with relevant delivery area.
- Cooperation and collaboration with statutory services to improve outcomes for residents.

PRIORITY 3: Promoting fairness, equity, and inclusion across our borough

Our ambition is to make H&F one of the most inclusive and accessible boroughs in the country; a place where everyone feels valued, and where residents have equitable access to the opportunities our borough offers. This means putting fairness, equity, and compassion at the heart of everything that happens in our borough and ensuring that all residents are factored into how decisions and services that impact them are made and provided. It also means having a strong and capable third sector that can help build stronger, more active, and more connected communities across our borough.

Outcomes Sought Residents from all backgrounds have equitable access to the community activities, P3.1 services, and peer networks they need without barriers, and residents who face barriers to inclusion are supported to challenge and overcome inequalities they face. P3.2 Local third sector groups are supported to work collaboratively, develop strong partnerships and rise to the current challenges facing our residents. P3.3 Residents who face barriers in accessing support services can access low-cost transport services which enable them to get the support they need. P3.4 Residents with autism experience a friendlier, more inclusive, and more supportive borough. P3.5 Residents are supported to tackle the barriers that prevent progression through mentor schemes to build resilience, confidence and self-esteem and help improve mental health. P3.6 Young people preparing for Adulthood and their parents or carers have greater access to information, advice and guidance as to benefits and support to mitigate against poverty and its impacts. P3.7 Refugees and migrants who are living in H&F are supported to integrate into local communities and access the services they need. PRIORITY 5: Making H&F a great place in which to live, work and thrive (includes arts, sports & culture)

Our ambition is for H&F to continue to offer London's best mix of world-class culture, creativity, and community arts, but also to build a borough with healthy, green, and accessible public spaces for an inclusive and sustainable future as we seek to make our borough the best place to live in London.

Outcomes Sought P5.1 More residents, from a wider range of backgrounds, participate in arts, culture, sports and heritage activities – including in venues and public spaces as creators, audiences, and leaders. P5.2 Residents from economically disadvantaged backgrounds who experience barriers to

The types of services that we will consider funding, include, but are not limited to services that provide access to high-quality cultural activities in the borough, demonstrating affordable and accessible arts and cultural experiences for residents who might otherwise find it difficult to participate, with a specific focus on:

- Activities involving artists with disabilities as leaders and creators, and/or engaging residents with disabilities as participants and audiences.
- Activities involving artists from diverse ethnic backgrounds as leaders and creators, and/or engaging residents from diverse ethnic backgrounds as participants and audiences.
- Activities that increase understanding between generations.
- Projects that make arts, culture and sporting activities more affordable and accessible to residents with low incomes.
- Projects that engage and educate people of all ages and backgrounds about environmental sustainability and the climate emergency.

Service Requirements

Due to the nature of services funded under this priority, organisations will need to demonstrate:

- A track record of artists being involved (eg by supplying biographical information, reviews, awards), where relevant to the service being offered.
- Plans for the recruitment of residents or marketing plans to attract audiences.
- Adherence to established pay rates for artists, including for preparation activities.

PRIORITY 6: Creating a safer and more resilient borough for everyone Our ambition is to put residents at the heart of everything we do, keep them safe, and work in partnership to safeguard our residents. This means holding criminals to account, deterring entry into crime, and ensuring the right services are in place at the right time to support victims and those at the greatest risk. **Outcomes Sought** Women and girls are supported and better protected from all forms of violence and P6.1 exploitation P6.2 Residents feel safer in the community and in their homes.
