- ➤ New grants commence 1 April, existing grants end 31 March 2025
- Up to £2.6m available after committed expenditure

- Promoting healthier, longer & more independent living
- Promoting fairness, equity, & inclusion across our borough (including supporting refugees & asylum seekers)
- Preventing poverty & its impacts
- Making H&F a great place in which to live, work & thrive including for sports, arts and culture.
- Creating a safer & resilient borough for everyone
- Tackling the climate emergency







Outcomes

- Outcomes are listed under our seven priorities.
- Outcomes are the result, effects or improvements that we want to see for residents.
- Need to show how you will measure delivery against your selected outcome(s).

What does good look like?



Applications will be assessed based on the following elements:

- Having a clear activity, project or service, with a strong case for how it will deliver one or more outcomes.
- Has clear and robust financial plans, monitoring indicators, and processes to manage the grant effectively.

- Shows clearly how they meet the following principles:
 - Collaborative
 - Inclusive
 - Preventative
 - Demonstrates impact
 - Well organised
 - Adaptable
 - Value for money.



Other things to note



- Read the whole application form, outcomes and guidance before applying.
- Ensure you are eligible and have consent to apply.
- We will assess only what is submitted in the application
- Be clear how your proposal will deliver the outcomes we want for residents and meet the principles for the fund.
- Speak with residents and your board.
- Tell us if your proposal supports protected groups (Equality Act)
- Save your application regularly.





Monitoring



- Grant agreements subject to agreeing performance measures.
- ➤ Enhanced monitoring for £35,000+
- Monitoring likely to consist of:
 - Quarterly reporting
 - Annual summary report
 - Annual site visit by H&F
