### North West London Healthcare Commission – Request for Documents

Thank you for your response to my letter of 5 February seeking access to documents that you had previously offered to our consultants. I am very concerned that you are unable to provide these. The failure to provide documents is not only contrary to the offer, but there is no satisfactory explanation for this failure. More importantly there is a clear inference from your response that Government policy has been and is being implemented on a basis that has not been finalised or fully formulated. At this distance of time from the launch of the plan how is it that so much is still only in draft form and unavailable?

We have now received the written submissions from the CCGs and these do include summaries of the progress of their Out of Hospital strategies but these are not satisfactory for our purposes, in that they fail to outline how their plans for the development of OoH services will impact on the business case for the strategies or be held accountable, e.g. they say they are planning on a 3.5% cut in non-elective activity for 2015/16 against the 2014/15 baseline but how does that match against the 2011/12 baseline in the original PCBC or DMBC and what are the implications of any discrepancy? Our consultants were promised a clear statement of the progress planned and achieved to date of the success of OoH strategies and what we have seen from the CCG submissions is not that.

I would like to know when you will be able to provide the Commission with copies of the Investment Making Business Case (IMBC) and the Tri-partite review of A&E performance in North West London as these will be key to our review.

When will the IMBC be published? Will we get sight of a final draft if this is not imminent? If not, why not?

The review of A&E closures was in draft form when you met with our consultants in January and due to be published at the end of that month. What has delayed the publication of this review and when do you now expect it to be published? Again, if this is not imminent can we have sight of a final draft? If not, why not?

We would now also like to see the minutes of all meetings of the Patient and Public Representative Group. I would be grateful if you could forward these documents by email to Peter Smith, Clerk to the Commission, at <u>peter.smith@lbhf.gov.uk</u>.

I am replying to your letter of 3 March 2015 to my colleague Thirza Sawtell and on behalf of all the Chairs and Chief Officers of NHS organisations in North West London.

I should begin by saying that we are all keen to co-operate with your healthcare commission and to provide you with as much information as we can. We wish to approach this matter in a spirit of openness and transparency and we hope you do too.

Your letter raises questions around three particular issues and makes a new request for some additional documents.

Specifically you raise the issue of the Investment [sic] Making Business Case (IMBC). We think you are referring to the Implementation Business Case (ImBC). You may be aware that this is simply one stage in the normal process of developing and implementing service changes within the health system. The ImBC is not currently completed and has not, therefore, been approved by the CCGs. In addition we have promised the Overview and Scrutiny Committees in the affected boroughs that we will make it available to them first, as soon as it is approved.

You also raise the matter of the Tri-partite review of A&E performance in North West London which was commissioned by NHS England, the NHS Trust Development Authority and Monitor. I am afraid it is not within the power of the North West London CCGs or local NHS Trusts to provide this document or any information about it. We would recommend that you approach NHS England about this document.

Furthermore, you raise the question of the CCGs' out-of-hospital strategies. I am grateful to you for acknowledging that the written submissions from the CCGs include information about their out-of-hospital strategies. However, you go on to say the information provided is not satisfactory for your purposes and you ask for " a clear statement of the progress planned and achieved to date". I will ensure that we prepare a statement that gives you more detail.

Finally, you ask for the minutes of the Shaping a Healthier Future Patient and Public Representative Group. We will certainly make these minutes available to you.

In the interests of openness, transparency and clarity for our local communities we believe it would be sensible and appropriate for us to agree with you the next steps as you proceed with your commission. We particularly feel it would be helpful for us to provide you with a single line of communication to NHS organisations in order that there is no confusion over which further documents you may require and who would be the most appropriate NHS representatives to provide you with these documents and/or to provide you with oral evidence.

I therefore propose the following course of action:

- That you provide us with a copy of all the evidence the commission has received and any other documents upon which you are proposing to rely. We assume this will include documents such as the paper entitled "Briefing for North West London Commission on Shaping a Healthier Future" dated 5 January 2015 and written by Seán Boyle and Roger Steer. By providing this evidence pack you will enable NHS representatives to review the evidence and then address any questions or underlying assumptions when we give oral evidence.
- 2. That you give us a full and final list of any further documents you may require in order to avoid confusion and to allow us to do our best to provide you with them.
- 3. We will then ensure that the appropriate NHS representatives make themselves available to give you oral evidence once we have had an opportunity to review the written evidence you have received along with any other documents you are relying upon.

We think it is unlikely that items 1 and 2 above will be completed before the end of this month (March 2015) and we therefore propose that oral evidence from NHS representatives should be scheduled for the session fixed in early May. If that is not convenient for you we would be content to agree another date soon thereafter.

I hope this successfully addresses the matters raised in your letter and provides us all with a sensible and effective way forward. I hope, in particular, that by offering myself as the conduit for any future enquiries you may have with NHS organisations in North West London we will be able to streamline our communications and move forward rapidly.

I can confirm that this approach is endorsed by all NHS organisations in North West London and for the purposes of clarity that no NHS organisation or representative will expect to provide you with oral evidence before your hearing in May 2015.

Thank you for your letter of 12 March in which you say you will provide the NHS with "the full extent of written evidence" submitted to you along with "the consultants' briefing paper presented to our first meeting". It is not clear from your letter, however, whether you may be receiving further written evidence as your commission proceeds and/or whether you may be relying upon documents other than the consultants' briefing note.

Like the Commission, the Programme team is committed to ensuring that your work is conducted in a completely fair way and that it reaches conclusions on a properly informed basis. You will understand, therefore, that if NHS witnesses are to be questioned it is sensible and appropriate that they should have had an adequate opportunity to review any/all of the documents they may be questioned on. It is, we believe, in the wider interests of your inquiry, as well as those of the witnesses, that they have access, prior to questioning, to <u>all</u> the evidence/documentation on which the Commission proposes to rely. Could you please, therefore, confirm that the documents you propose to make available to us represent the full extent of the evidence and other material upon which your commission will rely?

Once we have been able to review the totality of the material you are making available to us we will make further suggestions as to when NHS witnesses might appropriately give oral evidence.

Thank you for your letter of 14 March. I am pleased that the Commission's first oral evidence session went well.

I am surprised you think our position "entirely unacceptable and unprecedented" because it remains exactly as it was when I wrote to you on 11 March, namely that NHS witnesses are willing to offer oral evidence to your commission once they have had an opportunity to review the written evidence and any other documents upon which your commission proposes to rely.

Following my letter of 11 March you wrote to me to say that you "agreed to provide [me] with the full extent of written evidence submitted to us, as well as the consultants' briefing paper presented to our first meeting." The implication of your reply is that you acknowledge the importance of witnesses being properly and appropriately informed and prepared before they provide oral evidence.

To be clear, I simply want to ensure that when NHS witnesses give oral evidence they do so on a fully-informed basis, having seen, and had time to digest and consider, <u>all</u> the evidence about which they might be questioned. It seems to me that there is nothing unacceptable or unprecedented in that. In fact, any other approach would be unacceptable, as it would fly in the face of the normal principles of natural justice and fairness that I know you will be as eager as I am to uphold: and, of course, allowing witnesses to know the case on which they will be asked to comment is essential if the Commission is to receive the best possible evidence from them.

I am also somewhat confused by your offer to provide us with the "full extent of written evidence" submitted to you (your letter of 12 March) and your assertion that we "have all the documentation in any event" (your letter of 14 March). What about written evidence submitted by non-NHS organisations?

Perhaps it would be helpful if I clarified our position once again.

1. NHS organisations in North West London are keen to co-operate with your healthcare commission and to answer any questions you may have.

- 2. We would be grateful if you could provide us with all the evidence the commission has received and any other documents upon which you are proposing to rely. We will then ensure that the appropriate NHS representatives make themselves available to give you oral evidence once we have had an opportunity to review the written evidence you have received along with any other documents you are relying upon.
- 3. We think it is unlikely that this can be completed before the end of this month (March 2015) and we therefore propose that oral evidence from NHS representatives should be scheduled for the session fixed in early May. If that is not convenient for you we would be content to agree another date soon thereafter.
